# Overview

## Targeted reforms to deliver jobs, hospitals and houses for Western Australians

Reform of WA Government departments announced by WA Premier the Hon Roger Cook MLA on 31 March 2025 align with his new Government's priorities of a more resilient economy and a better way to build.

The reform is designed to drive the Government's goals of job creation through economic diversification, local manufacturing and energy transition; delivery of hospitals and other major infrastructure; and the building of houses across WA.

## Summary of changes

- 9 departments affected
- 16 departments not affected
- Net gain of one department
- Staff and teams assigned to departments by 1 July 2025 with full implementation expected by 1 January 2026
